Re: PRDE RESPONSE TO 10/16/19 USAC REQUEST FOR INFORMATION AND DOCUMENTS

Dear Catriona:

This letter and accompanying records are in response to your request for additional information and documentation pertaining to selected Puerto Rico Department of Education (the "Department" or "PRDE") FY2017, FY2018 and FY2019 E-Rate applications. A master list of the documentation (the "Master Document List") is attached to the cover email for this letter. The Master Document List is divided into the following five (5) Tabs:

Each request from USAC is restated below, followed by the Department's response, and all documentation has been posted in the Department's SharePoint account and can be accessed by USAC at http://intraedu.dde.pr/20182019USACRequest/2018%20%202019%20USAC%20Request/.

1. PLEASE PROVIDE DOCUMENTATION OF ANY REVIEWS THAT PRDE HAVE COMPLETED TO DETERMINE THAT THE ACTIONS THAT LED TO MS. KELEHER'S INDICTMENT DID NOT AFFECT ANY E-RATE FUNDING.

PRDE Response:

The Department's E-Rate program is managed by the Office of Technology ("OSIATD") in accordance with E-Rate Procurement Guidelines ("Guidelines"") put in place by OSIATD in 2012. The Guidelines are to ensure the Department complies with both E-Rate competitive bidding and local procurement

Both E-Rate and our local laws require open, fair and transparent bidding and vendor selection processes. The Puerto Rico Secretary of Education's involvement in the Department's E-Rate program is limited to (a) approving the requested designation of Evaluation Committee members upon request of the CIO, (b) execution of Notices of Award to the vendor(s) recommended by vote of Evaluation Committees, and (c) execution of E-Rate contracts and amendments as required by Puerto Rico law (e.g., annual appropriation of funds, exercise of options to renew, etc.).

The E-Rate Procurement Guidelines have been followed with regard to each of the funding requests under review, except for the FY2018 BMIC solicitation, which was conducted by invitation, in addition to the posting of an RFQ and Form 470 in the USAC EPC portal. An RFQ was used for the BMIC FY2018 solicitation pursuant to the E-Rate Emergency Procurement Declaration approved by then Secretary Keleher, following Hurricanes Irma and Maria. A copy of the Emergency Declaration is included with the FY2018 and FY2019 BMIC documentation posted in SharePoint.

With regard to the FRNs in question, please note the following safeguards that were in place to preserve the integrity of the process:

- The Law Department reviewed and approved all E-Rate solicitations, award letters and contracts, as well as the Emergency Declaration approved by Julia Keleher for post-hurricane solicitations.
- Our E-Rate consultant worked with OSIATD, Budget, Procurement, Federal Affairs, and Law to ensure we remained in compliance with both E-Rate and local competitive, contract and procurement rules and regulations.

Former Secretary Keleher did not attempt to influence the competitive bidding process or vendor contract awards pertaining to any of the Department's FY2017, FY2018 or FY2019 funding requests.

2. PLEASE EXPLAIN ANY INTERNAL CONTROLS CHANGES PRDE HAVE MADE IN RESPONSE TO THESE EVENTS.

PRDE Response:

As outlined in this response, the Department's E-Rate program is managed strictly by E-Rate and local procurement guidelines under the direction of the CIO, and with advice and instruction from our Law Department, Procurement Department and E-Rate consultant. After reviewing all records pertaining to the FY2017, FY2018 and FY2019 competitive bidding and contract awards, we find that the entire process was conducted in full compliance with E-Rate program rules. As a result, no new control changes have been implemented. We would like to note however, that the Department is in the process of hiring a Third Party Fiduciary Agent to provide independent oversight, management and administration of the Department's funds from the US Department of Education. Although the E-Rate program managed by OSIATD will not be subject to said oversight, the best practice methodologies and practices instituted by the Third Party Fiduciary Agent will be shared with offices receiving other federal funds, such as E-Rate, for implementation as appropriate.

3. PLEASE DESCRIBE JULIA KELEHER'S INVOLVEMENT IN PRDE'S E-RATE APPLICATION PROCESS, INCLUDING THE COMPETITIVE BIDDING AND BID EVALUATION PROCESS. THIS EXPLANATION SHOULD COVER ALL OF THE FUNDING REQUESTS THAT WERE IN PLACE DURING HER TENURE.

PRDE Response:

OSIATD is responsible for network infrastructure, Internet access and ineligible telecommunications services. With regard to these services, OSIATD and our technical staff and contractors, along with our E-Rate consultant, manage all aspects of our E-Rate program, without involvement or direction from the Secretary's Office. This work includes the following:

- RFP drafting, including identifying needed services and equipment, drafting technical specifications and outlining submittal requirements
- Hosting of pre-proposal vendor conferences
- Publishing written responses to vendor questions
- Conducting vendor oral presentations and product demonstrations
- Recommendations for Evaluation Committee Members (the Secretary appoints the member to ensure their participation)
- Selection of Evaluation Criteria and Weights
- Determination of required bid bond and performance bonds (with advice and direction from Procurement, Budget and Law)
- Preparation and filing E-Rate forms, including Form 470 and Form 471
- Determining the eligibility of products and services
- Determining the eligibility of sites
- Drafting Scopes/Statements of Work
- Drafting Service Level Agreements
- Preparation of Award Notices based on Evaluation Committee Vote

The selection of service providers is made by Evaluation Committee vote. No one from the Secretary's Office serves on E-Rate Evaluation Committees, and the CIO does not participate in the evaluation process, in order to preserve the autonomy and objectivity of the Committee. Moreover, no Secretary of Education, including Julia Keleher, ever questioned or attempted to influence or direct the awards recommended by the Evaluation Committees appointed with regard to the FY2017, FY2018 and FY2019 E-Rate FRNs in question. The extent of the former Secretary's involvement was limited to directing requested Evaluation Committee members to dedicate time to participate in the review process, and to signing award notices and contracts (including amendments).

The Master Document List identifies the individual(s) responsible for key actions involved with the competitive bidding, evaluation and contract awards for each of the funding requests in question. Please refer to the Master List for the comprehensive list. In addition, a summary of Julia Keleher's involvement with each Funding Request Number ("FRN") is attached hereto as <u>EXHIBIT A</u>.

4. PLEASE PROVIDE ANY DOCUMENTATION AND CORRESPONDENCE BETWEEN JULIA KELEHER AND ANY E- RATE-PARTICIPATING SERVICE PROVIDERS.

PRDE Response:

Because the Secretary's involvement with E-Rate is limited, we found very few communications between Julia Keleher and contracted service providers. Copies of the communications with service providers during her tenure are included in SharePoint for your review. The copies of the communications have been provided to us by the service providers to ensure we have all communications between the them and the former Secretary, because we otherwise do not have access to communications conducted by Julia Keleher using Telegram or cell phone texts. See the Master Document List for the reference number and location of the communications.

During the competitive bidding process, interested vendors are prohibited from communicating with decision-makers in the Department and must submit signed Anti-Collusion Affidavits with their proposals. In FY2019, the Department also instituted a "Cone of Silence" during the E-Rate bidding period to further protect the integrity of the process. The applicable language is set forth in Section 1.8 of the FY2019 WAN and Internet RFP, which provides as follows:

1.8 CONE OF SILENCE

The following communications related to this RFP between the persons indicated below shall be prohibited:

- A. A potential Proposer, service provider, Proposer, lobbyist, or consultant of a Proposer or potential Proposer or Proposer and the Department's professional staff. The professional staff includes, but is not limited to, the Secretary and the Secretary's staff.
- B. A potential Proposer, service provider, lobbyist, or consultant of a Proposer or potential Proposer or potential Proposer and any member of the Evaluation Committee for this RFP.
- C. EXCEPTIONS: Unless specifically provided otherwise in this RFP, the Cone of Silence does not apply to the following:
 - A. Communications with the Department Legal Division and its staff.
 - B. Oral communications at pre-bid conferences.
 - C. Oral presentations before the Evaluation Committee meetings.
 - D. Contract negotiations.

5. PLEASE PROVIDE COPIES OF PRDE'S PROCUREMENT POLICIES AND PROCEDURES THAT WERE IN PLACE DURING JULIA KELEHER'S TENURE AS SECRETARY OF EDUCATION.

PRDE Response:
