## **Additional Comments:**

Cisterns at bathrooms have electrical pumps. Unable to refill them. Neighbor lot has water accumulated. Clean up efforts on going.

# **Findings:**

Water and power intermittent. Power has low voltage. Five cisterns working except the ones with electrical pump. One classroom with vinyl tiles damaged. Fence damaged in three locations but areas are restricted to students. Clean up efforts ongoing

## **Recommendations:**

Install safety fence or tape at damaged fence locations; repairs electrical pumps to fill cisterns or have a water truck to refill them; and install tiles at classroom
