The exhaust fan covers flew off, some windows and screens are damaged or missing.

Building 3 has partially collapsed rolling doors and one fully collapsed rolling door. Building 4 has heavy water leaks on the ceilings of infirmary and electronics classrooms, the rooftop access door is fully displaced but available and the A/C consoles are partially displaced.

Additional Comments:

Findings:

1. Bldg #3 has displaced rolling doors and 1 fully collapsed. 2. Bldg #3, 4 has substantial water leak. 3. Both roofs of the basketball court collapsed. 4. Cover of the Exhaust fan in the kitchen was blown away. 5. Perimeter fence collapsed behind bldg #1.

Recommendations:

1. Barricade the area of the rolling door. 2. Clogged roof drains must be cleared of debris. 3. Collapsed basketball ceiling debris must be clear and barricaded. 4. Barricade the perimeter fence area and repair.
