This school has intermittent water service with low pressure and not in used cistern. It has a power line hanging in front of the Director office. Poor maintenance at the service area with hanging barbed wire. Lighting fixture hanging at the basketball court.

Recommendations:

To remove or relocate the hanging objects. To clean up the cistern and to increase the water pressure. To clean up and remove barbed wire at the service area. To contact the Contractor of the existing improvement job started last summer.
